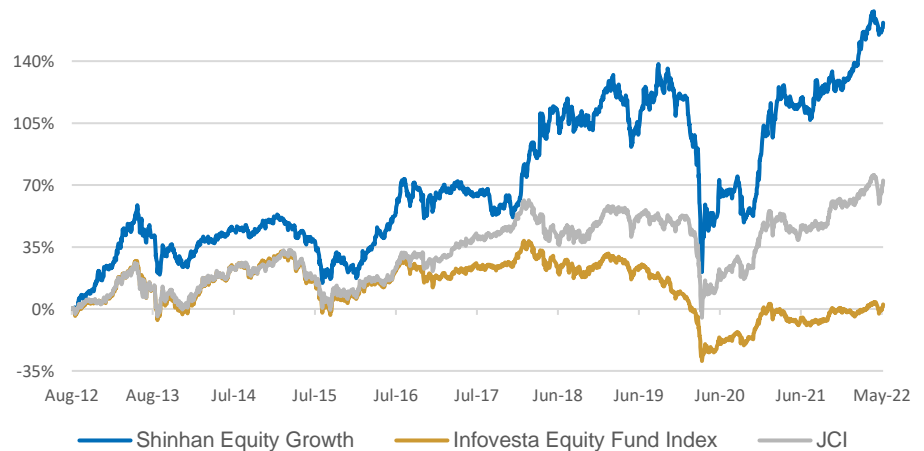

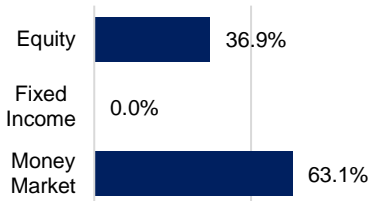
Performance Graph

Asset Allocation



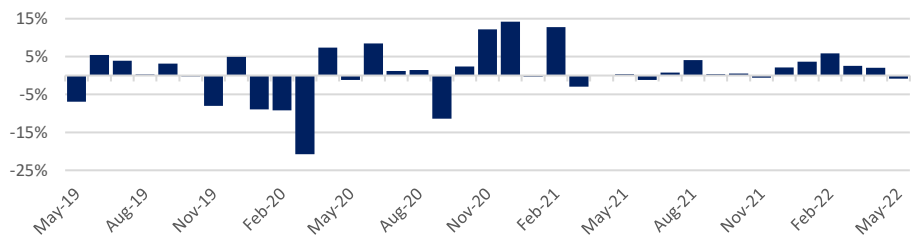
