

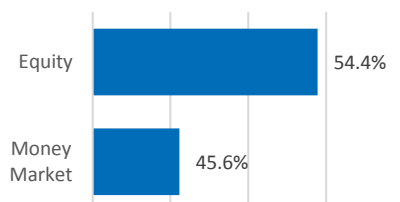

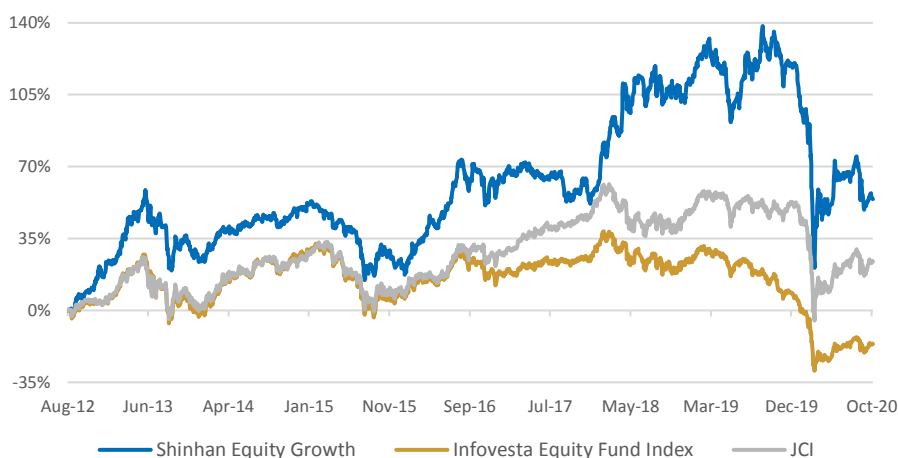

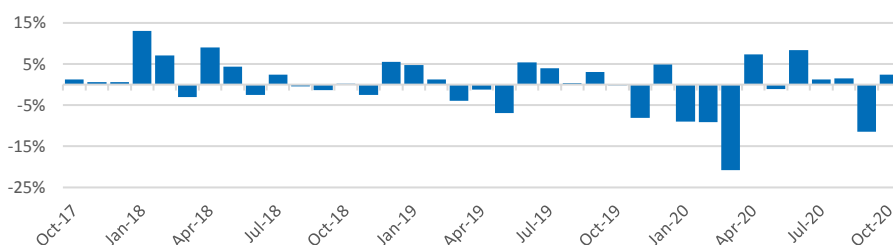
Performance Graph
