

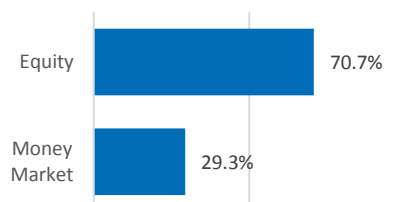

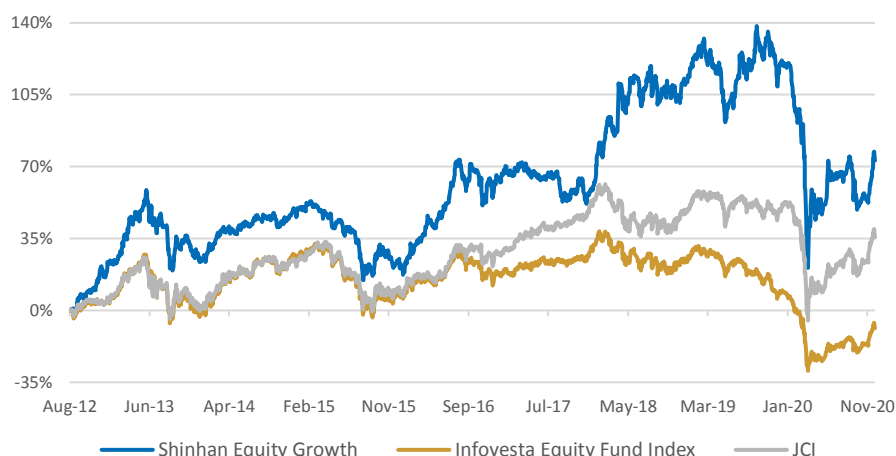

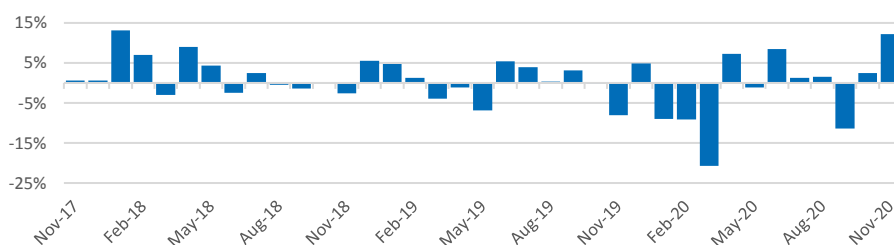
Performance Graph
