

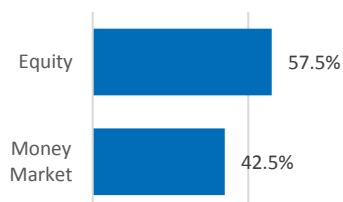

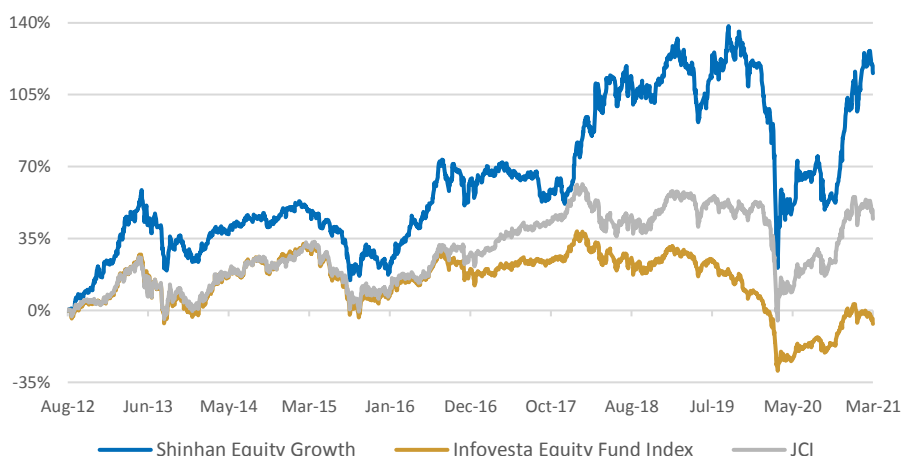

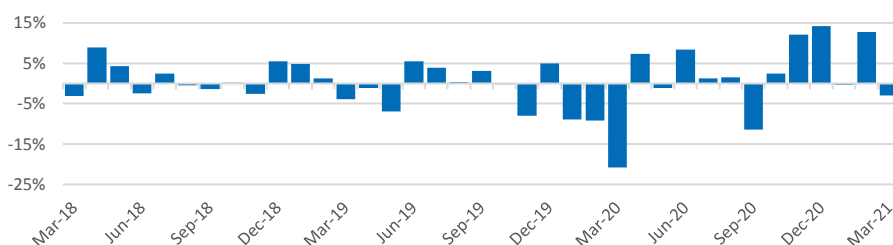
Performance Graph
